

# StoreFront Consulting, Inc Magento Extension End User License Agreement

CAREFULLY READ THE FOLLOWING LICENSE AGREEMENT. BY DOWNLOADING OR USING THE SOFTWARE YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, RETURN ALL SOFTWARE AND DOCUMENTATION TO THE PLACE OF PURCHASE FOR A FULL REFUND.

## TERMS AND CONDITIONS

### Definitions

"**Licensee**" means the person or company who is being licensed to use the Software or Documentation.

"**Software**" means the computer programs and technical documentation, and all Updates thereof being provided to Licensee and outlined in the applicable ordering schedules.

"**Updates**" means all published revisions and corrections to the printed documentation and corrections and new releases of the Software which are generally made available to StoreFront's supported customers at no additional cost. Updates shall not include any options or future products which StoreFront sells separately.

"**Designated Server**" shall mean the Server specified on the applicable ordering schedule with respect to a particular Software license. Such Server may be that of a third-party under nondisclosure obligations that will host the Software for the benefit of Licensee.

"**Server**" means each physical or virtual server from which a single instance of the Software is accessed and used for production purposes ("Production Server Instance"). For example, if one server contains two (2) instances of the Software, i.e., one Production Server Instance for domain A and one Production Server Instance for domain B, then a Server license is required for each of such instances.

### License Grant

Subject to Licensee's payment of the applicable fees and to Licensee's compliance with other terms and conditions of this Agreement, StoreFront hereby grants Licensee a

nonexclusive, worldwide license to use, modify and create derivative works in accordance with the Software's technical documentation solely on the number of Designated Servers specified in one or more applicable ordering schedules.

In the event that Licensee's actual number of Servers of a particular Software license exceeds the licensed number of Designated Servers on such license, Licensee shall promptly provide StoreFront with written notice and pay StoreFront the fees required to license such additional Server(s) in accordance with the commercial terms set out in the ordering schedule.

Licensee shall implement reasonable controls to ensure that it does not exceed the maximum number of licensed Servers of the Software. StoreFront reserves the right to audit Licensee's use of the Software during normal business hours and with reasonable notice and to include means within the Software to limit Licensee's use of the Software to the licensed number of Servers.

Licensee is authorized to use the Software on a single substitute or backup Server on a temporary basis without charge any time a Designated Server is inoperative due to a malfunction beyond the control of Licensee. Licensee may transfer the Software on a permanent basis to a single replacement Server without charge.

### **Title**

StoreFront remains the owner of all right, title and interest in the Software and related explanatory written materials ("Documentation").

### **Archival or Backup Copies**

Licensee may copy the Software for back up and archival purposes, provided that the original and each copy is kept in Licensee's possession and that installation and use of the Software does not exceed that allowed in the "License Grant" section above.

### **Transfers**

Licensee may transfer all rights to use the Software and Documentation to another person or legal entity provided Licensee transfers this Agreement, the Software and Documentation, including all copies, updates and prior versions to such person or entity and that Licensee retains no copies, including copies stored on computer.

### **Limited Warranty**

StoreFront warrants that for a period of 90 days after delivery of this copy of the Software to Licensee:

- the media on which this copy of the Software is provided to Licensee will be free from defects in materials and workmanship under normal use, and
- the Software will perform in substantial accordance with the Documentation.

To the extent permitted by applicable law, THE FOREGOING LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, AND STOREFRONT DISCLAIMS ANY AND ALL IMPLIED WARRANTIES OR CONDITIONS, INCLUDING ANY IMPLIED WARRANTY OF TITLE, NONINFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, regardless of whether StoreFront knows or had reason to know of Licensee's particular needs. No employee, agent, dealer or distributor of StoreFront is authorized to modify this limited warranty, nor to make any additional warranties.

SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION MAY NOT APPLY TO LICENSEE.

### **Limited Remedy**

StoreFront's entire liability and Licensee's exclusive remedy for breach of the foregoing warranty shall be, at StoreFront's option, to either:

- return the price Licensee paid, or
- repair or replace the Software or media that does not meet the foregoing warranty if it is returned to StoreFront with a copy of Licensee's receipt.

IN NO EVENT WILL STOREFRONT BE LIABLE TO LICENSEE FOR ANY DAMAGES, INCLUDING ANY LOST PROFITS, LOST SAVINGS, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE USE OR THE INABILITY TO USE THE SOFTWARE (EVEN IF STOREFRONT OR AN AUTHORIZED DEALER OR DISTRIBUTOR HAS BEEN ADVISED OF THE POSSIBILITY OF THESE DAMAGES), OR FOR ANY CLAIM BY ANY OTHER PARTY.

SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF

LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION MAY NOT APPLY TO LICENSEE.

### **Term and Termination**

This license agreement takes effect upon Licensee's use of the software and remains effective until terminated. Licensee may terminate it at any time by destroying all copies of the Software and Documentation in Licensee's possession. It will also automatically terminate if Licensee fails to comply with any term or condition of this license agreement. Licensee agrees on termination of this license to destroy all copies of the Software and Documentation in Licensee's possession.

### **Confidentiality**

The Software contains trade secrets and proprietary know-how that belong to StoreFront and it is being made available to Licensee in strict confidence. ANY USE OR DISCLOSURE OF THE SOFTWARE, OR OF ITS ALGORITHMS, PROTOCOLS OR INTERFACES, OTHER THAN IN STRICT ACCORDANCE WITH THIS LICENSE AGREEMENT, MAY BE ACTIONABLE AS A VIOLATION OF STOREFRONT'S TRADE SECRET RIGHTS.

### **General Provisions**

1. This written license agreement is the exclusive agreement between Licensee and StoreFront concerning the Software and Documentation and supersedes any prior oral or written agreements, negotiations or other dealings between us concerning the Software.
2. This license agreement may be modified only by a writing signed by Licensee and StoreFront.
3. In the event of litigation between Licensee and StoreFront concerning the Software or Documentation, the prevailing party in the litigation will be entitled to recover attorney fees and expenses from the other party.
4. This license agreement is governed by the laws of the State of Maryland.
5. Licensee agrees that the Software will not be shipped, transferred or exported into any country or used in any manner prohibited by the United States Export Administration Act or any other export laws, restrictions or regulations.
